Gov. Schwarzenegger Appoints Eleven to Los Angeles County Superior Court

Governor Arnold Schwarzenegger today announced the appointments of Michael J. Convey, Christine C. Ewell, Dianna J. Gould-Saltman, Brian M. Hoffstadt, James E. Horan, Upinder S. Kalra, Marc R. Marmaro, Timothy R. Saito, Chestopher L. Taylor, Carlos E. Vazquez and Yvette Verastegui to judgeships in the Los Angeles County Superior Court.

Convey, 50, of Valley Village, has served as a court commissioner for the Los Angeles County Superior Court since 2002. Previously, he was an attorney for Silva, Clasen & Raffalow from 1992 to 2002 and Nelsen, Thompson, Pegue & Thornton from 1989 to 1991. Convey was an attorney for Struckmeyer & Wilson from 1987 to 1998. He earned a Juris Doctorate degree from DePaul University School of Law and a Bachelor of Arts degree from Arizona State University. He fills the vacancy created by the conversion of a court commissioner position on July 27, 2009. Convey is a Democrat.

Ewell, 48, of Los Angeles, has served as chief of the criminal division for the U. S. Attorney's Office, Central District of California since 2007, previously held the positions of chief of the major frauds section from 2004 to 2007, special assistant to the U. S. attorney from 2002 to 2004 and an assistant U.S. attorney for the major frauds section from 1991 to 1996. She was counsel for O'Melveny & Myers from 1997 to 2000 and an assistant U.S. attorney in the U. S. Attorney's Office, Southern District of Texas from 1990 to 1991. Ewell was an associate attorney for Vinson & Elkins from 1986 to 1990. She earned a Juris Doctorate degree from Harvard Law School and a Bachelor of Arts degree from Texas A&M University. Ewell fills the vacancy created by the retirement of Judge Josh M. Fredricks. Ewell is a Republican.

Gould-Saltman, 51, of Los Angeles, has been a partner at Gould-Saltman Law Offices since 1997 and was a sole practitioner at the firm from 1994 to 1997. Previously, she was an attorney for the Law Offices of Lorraine C. Gollub from 1986 until 1994. He was a law clerk for the Honorable Sandra Day O'Connor, Associate Justice of the U.S. Supreme Court from 1996 to 1997 and the Honorable Cynthia Holcomb Hall, Judge of the Ninth Circuit Court of Appeals from 1995 to 1996. Hoffstadt earned a Juris Doctorate degree from the University of California, Los Angeles School of Law and a Bachelor of Science degree from California State Polytechnic University Pomona.
